

# Privacy Policy

## 1. General Information

This Privacy Policy sets out the rules for the processing and protection of personal data provided by Users in connection with their use of the services of the website [www.wroclavile.com](http://www.wroclavile.com) (hereinafter referred to as the "Service").

## 2. Personal Data Controller

The controller of personal data contained in the Service is Centrum Artystyczne Muza-Art, based in Wrocław, ul. ## 3. Purposes and Legal Basis for Data Processing

The Controller processes Users' personal data for the following purposes:

- a. Performance of a contract for the provision of electronic services
- b. Marketing of the Controller's own products or services
- c. Analysis of traffic on the Service, compiling statistics

## 4. Data Retention Period

Users' personal data will be stored for the following periods:

- a. For contract performance – for the duration of the contract and until the expiration of any claims arising from it
- b. For marketing purposes – until an objection to such processing is submitted
- c. For analytics and statistics – until an objection to such processing is submitted

## 5. Data Recipients

Recipients of Users' personal data may include:

- a. Entities processing data on behalf of the Controller, e.g., IT service providers, marketing agencies
- b. Entities authorized to obtain data under applicable law, e.g., courts or law enforcement agencies

## 6. Users' Rights

Users have the following rights regarding the processing of their personal data:

- a. Right to access their data and receive a copy
- b. Right to rectify (correct) their data
- c. Right to delete their data
- d. Right to restrict data processing
- e. Right to object to data processing
- f. Right to data portability
- g. Right to lodge a complaint with the supervisory authority (President of the Personal Data Protection Office)

## **7. Voluntary Data Provision**

Providing personal data is voluntary but may be necessary to use the Service or fulfill a contract.

## **9. Data Security**
